CONDITIONS & TERMS OF CONTRACT

ADVENTURE RENT 4X4 S.l. Is the owner of the brand Adventure Rent and owner and / or depositary of the vehicles offered to be rented according to the rental conditions below.

Implicit conditions of the rent.

The implied conditions will be applicable to the person who signs the Rental Contract and who provides as guarantee of the Vehicle, the corresponding credit card of which he/she is the holder. The person who rents the vehicle will assume all costs associated with the Rental Contract that subscribes, regardless of whether it appears as the driver of the rented vehicle as well as any driver expressly indicated in the Rental Contract, and therefore authorized to drive the vehicle.

All persons identified in the lease shall be jointly liable for any amount due under the contract.

In the event that the reservation has been made and prepaid by a third party, other than the lessee, understood as such to the person who signs the rental contract and holds the credit card provided as collateral, and the mentioned third party will reject Adventure Rent charge, the renter will charge the authorized drivers included in the Rental Contract as they will be liable of the payment of the rental amount.

To rent and drive a car from Adventure Rent.

Any physical person can rent our vehicles.

Provided you are legally able to subscribe a contract with Adventure Rent and you are prepared to accept responsibility for the Vehicle during the Rental Period and to hold the means of payment accepted by the local company of Adventure Rent. Those are: credit cards VISA or MasterCard that will be charged to pay the rent of the Vehicle and the associated costs and who provides identification documents valid in force and validity including: European identity document or passport For non-EEC and valid driving license. All documents must be original, no copies are accepted.

Only the authorized driver(s) of the Vehicle may drive it and must meet the following requirements:

- Name and identification is expressly mentioned and fully identified in the Rental Agreement
- Provide a valid driving license and a valid identification document (Identity Document or Passport)
- Have a valid driving license with a minimum of 3 years in the year and is older than 25 years depending on the category of the Vehicle in the terms indicated in this document.

Explicitly, non authorized to drive the Vehicle are those persons who are not expressly mentioned/identified in the Rental Contract as well as those persons who do not provide valid identification documents as indicated in this section.

If the lessee of the vehicle allows an unauthorized person to drive the Vehicle, this will be considered a breach of the terms and conditions of the contract and will be responsible for the consequences that may result from this fact, including the possibility to respond to Adventure Rent of Damages caused by You and/or by such unauthorized person. In such circumstances, neither the lessee nor the unauthorized driver may be covered by protection or insurance products offered through Adventure Rent.

In this case, the unauthorized driver will not be covered by any insurance or protection products offered by Adventure Rent with the exception of the Automobile Obligatory Liability Insurance that will be applicable in any case.

Geographical scope of use of the vehicle

You may drive the Vehicle in the countries or territories listed below

The use of the Vehicle-Tourism is only allowed in Mainland Spain and the territory of Gibraltar and Portugal. All terrain 4x4 vehicles are only allowed in Spain and Portugal.

Please note that you must comply with the traffic rules of the country in which the leased Vehicle is being driven.

Use of the rented vehicle

You can rent a touring car, a van or a motorcycle and you must drive the Vehicle according to its ordinary use in the following way:

- Passenger cars are intended for the transport of a variable number of persons (depending on the authorized capacity of the Vehicle) for non-professional or commercial purposes
- Vans and 4x4 vehicles can be used for the transport of people according to the authorized capacity of the vehicle, as well as goods up to the weight limit on the Vehicle Permit and / or Vehicle Data Sheet.

In no case, Adventure Rent covers the objects transported in the vehicle and assumes no responsibility for those properties or objects left by forgotten inside the vehicle. Also, Adventure Rent is not responsible for any consequential loss or damage that may be involved in the execution of this rental.

Explicit commitment of the person who rents a car to Adventure Rent:

- When renting an Adventure Rent Vehicle, the registered driver and/or any authorized Driver must fulfill the following obligations:
- You must return the Vehicle and its keys, accessories and documentation to the Adventure Rent station mentioned in the Rental Agreement, on the date and time of expiration specified in said Contract (there is a courtesy period of 30 minutes). In case you do not return the Vehicle in the terms indicated above, Adventure Rent may take all necessary measures described in the present T & C and
- Neither You nor any Authorized Driver can drive the Vehicle outside the defined scope of use (Spain, Portugal and Gibraltar). In addition, it must be ensured that when the vehicle is collected, that it has the correct equipment to comply with the local driving regulations of the country in which you and/or the driver are going to drive it.
- You and / or the Driver must drive the Vehicle judiciously and in accordance with all applicable traffic laws and regulations, and must ensure that you and / or the Driver are familiar with all applicable local driving regulations.
- If the vehicle is used for the transport of persons of 135cm or less in height, you must inform Adventure Rent that the latter will deliver the corresponding mandatory retention device (basic cost may be involved), without anchoring it to the vehicle, in accordance with Weight and size of the child or person to be used, together with the instructions detailed by the manufacturer of the child for the correct placement of the chair and the child or person to be used. Adventure Rent will not be obliged to carry out the installation and / or placement of such mandatory restraint device in the vehicle, limiting itself to complying with the aforementioned obligation to deliver the same prior communication from you.
- In any case, Adventure Rent shall be free from any liability arising from personal or material damages that may occur as a result of your failure to comply with the communication obligation, as well as the non-use of the mandatory or retention device. Its installation or incorrect use and any possible manufacturing defect of the mentioned obligatory retention device.
- You must ensure that all luggage or goods carried on the Vehicle are secured in a way that will not cause damage to the vehicle or cause risks to passengers.
- You and/or the Driver must carefully guard the Vehicle with the proper diligence of and responsibility and, in any case, ensure that it is closed and protected by the anti-theft devices when parked or left unattended.
- You and any Authorized Driver agree not to ever drive the Vehicle or to let it be used under the influence of alcohol, hallucinogenic drugs, narcotics, barbiturates, other illegal substances or any other substance (whether legal or illegal) that may interfere with your own driving ability or that of the Driver.
- You and / or the driver must refuel the vehicle with the appropriate type of fuel. If an improper fuel is filled and unless it proves that the error is attributable to a third party, you will be responsible for the expenses incurred by the transfer of the Vehicle and / or for the repair of the damage caused to it.
- Neither You nor the Driver may use the vehicle or allow the vehicle to be used:

- To lease, mortgage, pawn, sell or otherwise offer as security both the Vehicle or any part thereof, such as the Rental Contract, keys, documentation, equipment, tools and / or any of its accessories or parts of the car.
- To carry passengers for profit unless expressly authorized by Adventure Rent.
- Carry a higher number of people than the one established in the Circulation Permit and / or Vehicle Inspection Sheet.
- To transport flammable and / or dangerous, toxic, harmful and / or radioactive goods, or that violate current legal provisions.
- The transport of goods with a weight, quantity and / or volume greater than that authorized in the Vehicle Circulation Permit and / or in the Technical Inspection Sheet.
- To race, off-road circuits, resistance tests of materials, tests of speed or participation in rallies, competitions or any contest or trial, regardless of location, official or not.
- To transport live animals (except pets and / or pets, subject to the express authorization of Adventure Rent).
- To pushing or towing another vehicle or trailer (except when the Vehicle which is rented already has a trailer hook, with a maximum play load of 750 kg).
- To drive on gravel tracks or roads not suitable for motor vehicles or whose surface or condition implies risks to the tires or the underside of the Vehicle, or to the Vehicle itself, such as beaches, inadequate roads, forest tracks, mountains, etc. Which are not authorized, and unpaved roads, unless expressly authorized in writing by Adventure Rent.
- To commit intentional crimes.
- Transportation on board any type of boat, train, truck or plane unless Adventure Rent has given express authorization for it,
- During the rental, you and/or the Driver must take all necessary protective measures to keep the Vehicle in the same conditions as it had at the time of collection. In particular, you and / or the driver carry out mandatory inspections of the condition of the vehicle such as oil and water level, tire pressure.

You may be held liable against Adventure Rent for any detrimental consequences resulting from breach of the above mentioned obligations. Please note that failure to comply with these obligations may limit your right to compensation for damages that you may claim. In this case, Adventure Rent reserves the right to demand the immediate return of the Vehicle.

Roadside assistance.

Exclusions to Attendance Coverage

- Liability, negligence or misuse of the vehicle by the Lessee.
- Loss of keys, breakage or abandonment inside the closed vehicle.
- Inadequate fuel or refuelling due to fuel starving.
- Rescue of vehicles in places or roads that are not suitable for driving or unpaved.
- Defective placement of accessories on the vehicle by the Lessee.
- Battery exhausted.

In the case of mechanical breakdown, accident, vehicle damage or theft of the vehicle.

A situation that prevents you from continuing your journey and / or stopping the Vehicle to avoid causing a breakdown, has a roadside assistance service, included in the price of your rent. If you wish to use such service, you should call the toll-free telephone number below.

In the event of an accident, you must inform us within 24 hours from the time the collision or accident occurred and, in any case, before the end of your rental period by calling to our office phone. You must also give us a fully completed part of the accident and any other document that you think might be useful to supplement your statement.

In case of theft of the Vehicle, you must report the facts reported to our office, delivering the original of the complaint within 24 hours of its formalization, except in situations of force majeure, and in any case before the end of the lease period agreed upon. With the original keys of the Rental Vehicle, will entitle Adventure Rent to terminate the contract in full and claim the immediate return of the Vehicle. In this case, Adventure Rent may terminate the obligation and require the immediate payment of all outstanding debt regardless of the terms of payment previously agreed upon.
